**Submission of Online Proposals for Approval of Fees
for Government Approved Short Term Courses Affiliated to MSBTE
for the Academic Year 2025-2026**

All unaided institutions conducting Government approved Short-Term Courses affiliated to Maharashtra State Board of Technical Education are hereby informed that the Norms for fixation of fees for the Academic Year 2025-26 are published by the Fees Fixation Committee on 24.01.2025 after considering suggestions from stakeholders.

Based on these Norms, Institutes shall submit online proposal by accessing the portal using the User-ID as MSBTE Institute code and the password provided by the Fees Fixation Committee through e-mail to the respective Institutes. The separate link for submission of the online fees proposal will be made available on "msbteffc.in".

All the Institutes conducting Government approved Short-Term Courses are hereby informed that it is mandatory to submit online proposals for fixation of fees for the Academic Year 2025-26 within the prescribed time period with the applicable fee as given below,

From	To	Applicable fee
21 May 2025	25 June 2025	Processing fee
26 June 2025	10 July 2025	Processing fee + Late fee ₹10,000
11 July 2025	25 July 2025	Processing fee + Late fee ₹20,000

The processing fees shall be accepted through online payment gateway only. The copy of receipt generated after payment of the processing fees shall be submitted with the hard copy of the proposal as proof of payment. The committee has decided not to charge Processing Fees from the institutes who have submitted Fees Proposal and paid Processing fee for the Academic Year 2024-25.

After submitting the online proposal, the Institute shall submit a hard copy of this online submitted proposal within 7 days of submission of the online proposal. The List of Documents to be attached (Volume A&B) with the hard copy of the online submitted proposal for Short Term Courses for A.Y. 2025-26 is available on the web site www.msbteffc.in. The hard copy to be submitted must contain documents as per the list and properly arranged and paginated with an index. The institute must select an appointment on the msbteffc.in site for submission of hard copy of the proposal.

The proposal submitted without payment of processing fees and hard copy of the proposal shall not be entertained and processed. The institute shall be responsible for the future consequences arising out of this if any.
