for the Academic Year 2024-2025**

It is mandatory to **All Unaided Institutes** started from and before Academic Year 2022-23 to submit the fees proposals for fees fixation for the Academic Year 2024-25.

It is observed that some Diploma institutes have not submitted online proposal for fees fixation for the Academic Year 2024-25 despite above mentioned repeated notices by the Fees Fixation Committee from time to time. It is also observed that these institutes are participating in the centralised admission process being conducted by Directorate of Technical Education for the Academic Year 2024-25 and now requesting for allowing them to submit online application of Fees Fixation for Academic Year 2024-25 to the Fees Fixation Committee.

Considering such request all unaided institutions conducting Diploma in Engineering, Pharmacy, Architecture, Hotel Management and Catering Technology courses and affiliated to Maharashtra State Board of Technical Education are hereby informed that,-


To provide a last opportunity to the Diploma Engineering, Pharmacy, Architecture, Hotel Management and Catering Technology institute the link for submission of the online fees proposal will be made available on www.msbtfffc.in from **20/08/2024 to 28/08/2024**.

The Institutes are required to pay Processing fee with late fee of **Rs 1,00,000/-** as penalty. The proposals submitted without payment shall not be treated as confirmed.

The processing fees shall be accepted through online payment gateway only. The copy of receipt generated after payment of the processing fees shall be submitted with the hard copy of the proposal as proof of payment.

After submitting the online proposal, the Institute shall submit a hard copy of this proposal within 7 days of submission of the online proposal. The hard copy to be submitted must contain documents as per the Checklist and properly arranged and paginated with an index. The List of documents (Volume Part-A & Volume Part-B), Annexure-A and Affidavit are available on the web site www.msbtfffc.in

The proposal submitted without payment of processing fees and hard copy of the proposal shall not be entertained and processed. The institute shall be solely responsible for the future consequences arising out of this.
